
MID-WINTER AT ALPHA DELTA PHI

Executive Councilman Young Discusses National Problems, Activities in Talk to Undergraduates

Brother John M. Young '28, Cornell's representative to the Executive Council, gave a talk to the undergraduates in December on the activities of the Executive Council. Outlining the organization of the council, and giving a general idea of its policies, Brother Young told of some of the problems the council has faced.

Young discussed the rehabilitation of the various chapters atter the war, and the crowded living conditions in many of the Houses. He mentioned the tendency in some colleges toward the abolishment of the fraternity system, and warned that the conduct of each and every fraternity man was of utmost importance to the continued success of the fraternity. The Alpha Delt song album, and the new policy of

sending the minutes of the Executive Council to the individual chapters were other topics with which he dealt.

The council as a whole is interested in the broad policy aspect of the fraternity. Representatives make arrangements for the yearly national convention, the expansion of new chapters, controlling the Seward Scholarship Fund, and sponsoring of the literary contests.

Young deplored the absence in many of the chapters of the urge to literary endeavor. He pointed out that the council does not want to exert pressure on the individual chapters to conform rigidly to its policies, but would like to work hand in hand in controlled discussions with them. The House appreciated Brother Young's visit and talk.

Grosse Pointe, Mich., Trío Gain Top Offices; Cudlip Is President

Three Alpha Delts from the same home town—Grosse Pointe, Mich.—were chosen as the three top House officers for the Spring term at elections held in January.

Jack Cudlip '48 gained the presidential chair, Hilary Micou '48 was elected vice-president, and Jim Kennedy '50 moved into the secretary's post. Cudlip replaces Alabaman Vern Whitaker '48, while Micou takes the position held last term by Ben Huske '48 of North Carolina.

James Thomas '50 succeeds Hil Micou as rushing chairman and Cornelius "Nick" Reid '49 was named new social chairman. Lewis "Newt" Thomas '51 was elected to the athletic chairmanship, and Roger Brown '50 was unanimously reelected as historian.

Whitaker, retiring president, deserves our plaudits for the fine job he performed during the past term, as does Huske, who helped to keep House affairs running smoothly.

Cudlip was rushing chairman in the fall of '46, and social chairman last fall. He is president of Kappa Tau Chi, Administrative Engineering Society, and on the Board of Managers of the Ski Club. Micou is a Cornell cheerleader, former editor of The Alpha Delt, and a varsity trackman. Both Brothers have been otherwise active in the House and on the campus.

Jim Kennedy, third Grosse Pointe contribution to the Senate, has gone far since his arrival in the fall of '46. Jim will be one of the mainstays of the varsity tennis team this spring, after his splendid record on the frosh squad last season.

The House has already seen Nick Reid in action as social chairman. Reid and retiring so-
