

The 117th International Convention of Alpha Delta Phi will be held at Cornell University on June 23, 24, and 25 of this year.

Twenty-seven years have elapsed since the Brothers last gathered on the campus of Cornell "Far Above Cayuga's Waters." During those 27 years, the International Conventions have been held on many campuses throughout the United States and Canada, but once again Cornell has the honor of acting as host, and once again Cornell can show why it has been called by author John Gunther (in "Inside U. S. A.") "perhaps the most beautiful college campus in the United States."

Plans for the Convention are well under way. All of the undergraduates and some alumni of the Cornell Chapter have given their free time, and many problems have been solved already. Arrangements for the banquet are in the final stages of completion. Housing accommodations have been made. The cocktail party needs only a large number of delegates and guests to give it the final touch, and final contacts are being made with guest speakers.

The Chapter house at Cornell has been selected as the site for nearly all the functions of the Convention. The business meetings will be held in the very spacious living room, and the breakfasts, luncheons, and buffet supper will be held in the house also. Cornell's Chapter house is the largest on campus, and the most beautiful, and there is ample room for all the various Convention features.

Chapter Mourns Death of Hoopes, Paper Manufacturer, and McVoy, Underwriter

Martin McVoy, Jr. '92, president of Industrial Underwriters Inc., of New York City, died at his home in the Hotel Dauphin, Broadway and 67th St. in New York. on January 8, 1949, after an illness of five months.

An expert trapshooter, McVoy, representing the New York Athletic Club, was the first to shoot 100 out of 100 in a meet at Travers Island. He was chairman of the committee that organized the Olympic trapshooting team that represented the United States in the 1920 Olympics.

In the period just after the first World War, Brother McVoy was a dollar-a-year man in Washington, aiding in the demobilization. At one time he was chairman of the building committee of the Cornell Alpha Delt chapter.

Johnson, Kiplinger Added To Alpha Delt Pledge List

Two additional men, a Civil Engineering freshman and a junior in Arts and Sciences, have been added to this year's pledge class. Martin L. Johnson, the Civil Engineering frosh, hails from Plainfield, Vt. He is a veteran, having served for two and a half years in the Engineers as a 1st Lt. Martin has started off well, by being elected as the freshman representative of the Civil Engineering Honor Council. He's also a good and enthusiastic skier, and is already a member of the Ski Club and the Ski Patrol.

The other new member is Willet B. Kiplinger, Arts and Sciences junior who is majoring in economics. Will, a transfer student from Duke University, is from Snyder, N. Y. He has worked on the Junior Week committee, has been one of the mainstays of the Alpha Delt intramural basketball squad, and is a member of Scabbard and Blade, honorary society of the Reserve Officer's Training Corps at Cornell. The Chapter welcomes both of these men into the fold.

Maurice Hoopes '91, who retired as president of Finch, Pruyn & Co., paper manufacturers, in January and became chairman of its board of directors, died on February 15th of this year in Glens Falls, N. Y., at his home at 95 Warren St., after a brief illness. He was 78 years old.

One of Glens Falls' best known businessmen, Brother Hoopes was chairman of the board of directors and former president of the First National Bank, and was a director and a member of the executive committee of the Glens Falls Insurance Co., the Glens Falls Indemnity Co., and the Commerce Insurance Co. He was president of the Glens Falls Hospital Board of Directors from 190 to 1924.

A native of West Chester, Pa., Brother Hoopes was educated in private schools there and in Philadelphia, Pa., and was a member of the class of '91 at Cornell.

In 1904 he came to Glens Falls to make his home, joining Finch, Pruyn and Co. He was elected a vice president of the company in that year, and in 1908, upon the retirement of Samuel Pruyn, became president, a position he held until the annual meeting of the con-pany on Jan. 10th of this year, when he became chairman of the board, and his son-in-law, Lyman A. Beeman, a former vice-president of the St. Regis Paper Co., became president.

Before coming to Glens Falls, he served as superintendent of the Edison Electric Illuminating Co. of West Chester and the West Chester Street Railway Co. He also had been electrical engineer of the Lynn & Boston Railroad, general manager of the Albany & Hudson Railway and Power Co., and engineer with J. G. White & Co. of New York City.

Peter Kipp Clough '45-'47' is a real estate and insurance employee of Birtwhistle & Livingston of Englewood, N. J. Pete lives at 275 Booth Ave. in that city. A former Coast Guardsman, he belongs to the Cornell Club of New York.

Newton '05, Businessman, Financier, Reorganization Expert, Expires in Denver

Wilbur Newton '05, businessman and financier whose special skill was reorganization, died December 19, 1948, in Denver, Colo., at the age of 65. He had been in poor health for several years.

Bro her Newton was treasurer of the University of Denver, a trustee of Clayton College, and a director of the International Trust Co. As an appointee of the United States district court, he directed receiverships involved in several important bankruptcy

Born in Pueblo, Colo., Brother Newton operated the Newton Lumber Co. in that city, a firm established by his father, the late Whitney Newton, Cornell Alpha Delt Class of '79. Newton went to Denver in 1926, becoming associated with the Newton Investment Co. and the Ideal Cement Co. for several years.

More recently, he engaged in university and business firm financial reorganizations. During World War II he was volunteer executive for tire rationing. A scholarship fund will be established at the University of Denver in the name of Wilbur Newton.

Editorialized a Denver daily paper after the death of Brother Newton "... a man with peculiar talents which would have made him immensely wealthy if he had had ambilions along that line.

"Fortunately for thousands of small investors, Mr. Newton chose to devote his talents for the general good and not merely for personal gain. Mr. Newton was an expert diagnostician of the ills of faltering business vertures.

"If a failing company was beyond resuscitation, he had the knack of salvaging the largest possible amount for the creditors and stockholders. Mr. Newton's public service was of an unusual kind. He will be sorely missed."
