Of course, to welcome you will be a full house and many brothers from years past.

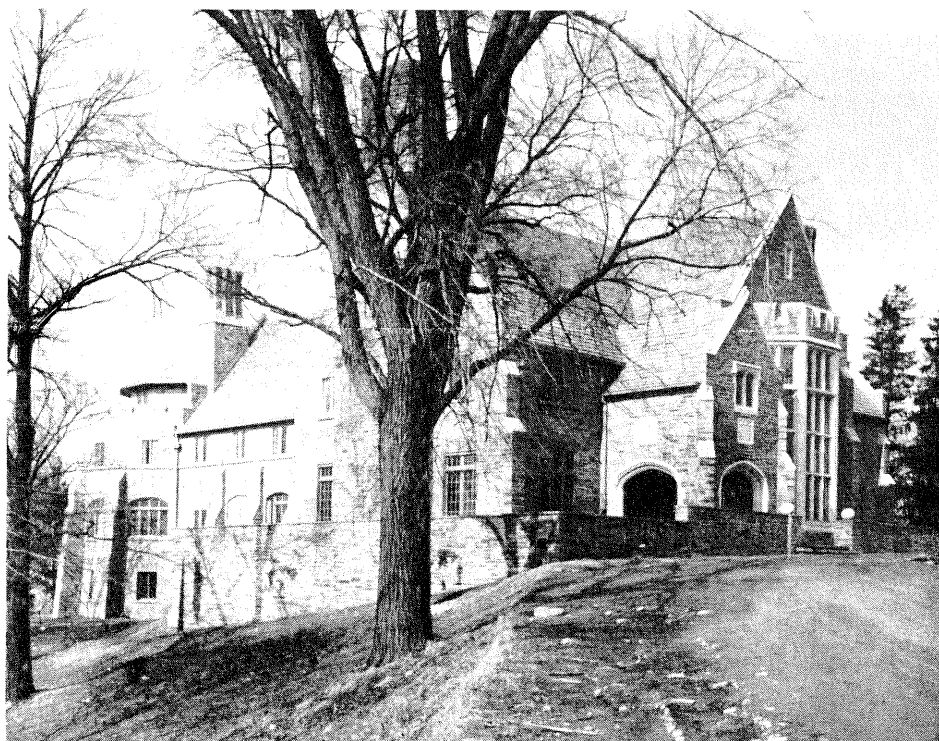

What you possibly don't know about the Republic of China. Source: **China News** May 1981

This is the Republic of China. It has been so since January 1 of 1912.

The name of the country is not Taiwan or Taipei. The people are Chinese. They may or may not be Taiwanese, just as Americans may or may not be Texans.

On the mainland, the Chinese Communists call themselves the "People's Republic of China;;.

Because of the existing Chinese political situation, people in the outside world tend to speak of "Taiwan" and "China".

We can understand that, even if we don't

condone it. What we do not understand is that the world media's studied avoidance of the Republic of China as the name of this country.

The Wall Street Journal and *Asian Wall Street Journal* are highly respected newspapers and among the most objective and responsible anywhere.

The Asian Wall Street Journal recently published a story about the Republic of China's purchasing mission in the United States. It is interesting and informative.

In 17 paragraphs, there is not one mention of the Republic of China. Taiwan or Taiwanese are used more than 30 times to identify the Republic of China.

At the very outset, the article speaks of "Taiwan's lack of diplomatic status" in Washington. Taiwan never had diplomatic status there or anywhere else.

There is no "Taiwan buying mission". There are no unofficial representatives of Taiwan in the United States or elsewhere. Taiwan does have a provincial government. But the national government is that of the Republic of China and not of Taiwan. The Taiwan Board of Foreign Trade is a misnomer. The BOFT belongs to the government of the Republic of China.

Fair is fair. Americans are not obtuse. Their media have just experienced a big flap about the inventions of a young reporter of the *Washington Post* who had to give back a Pulitzer prize.

Deliberately misrepresenting the Republic of China as Taiwan is far more serious than making up the story of a waif who took heroin.

An injustice is being committed against a country which currently has nearly 18 million people under its jurisdiction and is more important to world trade than the China of the mainland.

What's in a name? Shakespeare said that a rose would smell as sweet by any other name.

This is a matter of politics, not of roses.

Behind the Taiwan identification is the loss of Chinese identity in the eyes of the outside world. It is a concession to the Chinese Communists, even though those who relegate us to Taiwan may not have that intention.

For the most part, however, the outside world is not a party to Communist conspiracy. The use of Taiwan is merely handy and a course of least resistance.

Some media will argue, too, that the use of China for both this country and the mainland regime is confusing. It is true that a lot of people don't know the difference.

We are not asking to be called "China" except in circles that understand our entitlement to the name and our intention to regain it de facto.

For purposes of national and political identification, we ask to be called the

Republic of China. That is not only fair but accurate. Taiwan and Taiwanese are inaccurate.

Taiwan is a place name. There is nothing wrong about saying that someone has gone to Taiwan. To speak of U.S. trade with Taiwan is understandable, even if we would prefer to specify the Republic of China.

On the other hand, Taiwan does not have a government which negotiates with others and sends purchasing missions abroad to buy a billion U.S. dollars worth of a friendly country's goods.

Why is the rectification of names so important? Because the Republic of China is a good deal more than Taiwan. To deny this is to misunderstand the whole Chinese situation and to accept the Chinese Communist assertion of a monopoly on China, Chinese and even the Chinese republican form of government.

Possibly there is something we can do. If our government wrote to all the major media in the world asking to be called by its right and proper name and explaining why, foreigners might hear and see the Republic of China mentioned once in a while. That would at least be a beginning.

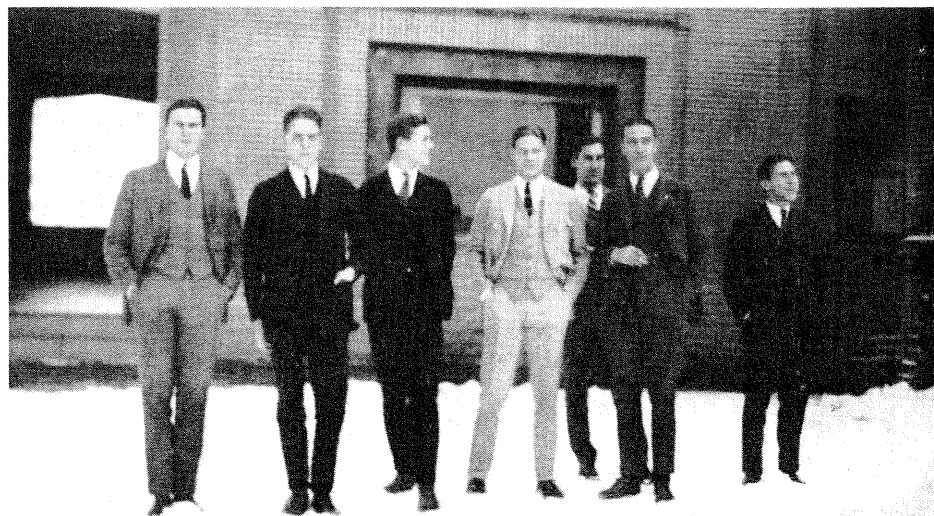
